

Hunters Glen & Cove “Who to Call” (or contact) List



Fire, Police or Ambulance / Emergencies - call 9-1-1

- Henderson County Sheriff (non-emergencies): 828-697-4912
- Etowah Fire station (non-emergencies): 828-891-3102

Water issues: Hendersonville water - call 828-297-3063 or 891-7779

For homes *above* 505/512 Hunters Glen Lane “no water” can be caused by no power (call Duke Power - # below) or a problem at the pump station located across from 505. Homes below 505/512 Hunters Glen call Hendersonville Water.

Noise: Henderson County has its/our Noise Ordinance posted on website <http://www.hendersoncountync.org/> (under “View Regulations”) - with more restricted noise controls from **11 pm - 7 am**. If you experience noise issues, call the **non-emergency county # 828-697-4912**.

Power outage: call Duke Power at 800-769-3766.

State Police (auto accidents, etc.): 800-445-1772 / 693-4141

Sewer system: If you are on the sewer system (not all homes are) call the # posted on your bill (A & D Water System - 828-884-9772).

Before digging a hole (to protect utilities) call: 8-1-1.

Animal Enforcement - 828-697-4912. For lost/found pets call Animal Services at 828-697-4723. They have recommend posting a notification on www.Craigslist.org

Going to be gone during sometime during winter months (?) - the Board suggests you give your emergency phone # to your "watch captain". **Note: your contact info would only be used if there were a visible-from-street emergency (fire or water running from house, for example).** **AND: consider turning your main water valve to “off.”**

Snow or tree removal (on roads): NC DOT (Road) Maintenance: **828-694-7971**. (FYI: DOT’s priority is snow removal on major roads & highways first.)

Waste Management. Home owners choose their own waste removal service. The Henderson county Recycling center can be reached at: 828-694-6524.

Community Watch: If you have an incident, please contact Sheriff or appropriate County Office (noted at top) as needed, then report to Block Captain later.

HOA newsletter: Published Spring and Fall and in between as needed.
